

Summer of Fun Promotion Rules

1. **NO PURCHASE REQUIRED:** There is no purchase necessary to win and purchasing Mississippi Lottery products does not increase the chance of winning.

2. **WHO CAN ENTER:** The Summer of Fun promotion is open to anyone 21 years or older who has signed up on the Mississippi Lottery website to be a “Mississippi Lottery Insider.” Lottery employees, retailers and vendors, and their immediate family members residing in their household, are not eligible to win any Summer of Fun promotional prizes.

3. **DRAWING PROCEDURE:** One week prior to the specified Summer of Fun drawing, the Insiders will receive an email and link taking them to an electronic entry form. Completed entries must be submitted by the midnight before the drawing date.

Each Summer of Fun drawing will have a unique entry form, and Mississippi Lottery Insiders will be encouraged to submit entries for each drawing. Entry forms from previous drawings do not carry forward. Each entry form will include images of the top prizes and a list of each prize available for the drawing. Winners from previous drawings not prohibited from entering new drawings. Each submitted entry is valid for the specific drawing only.

4. **DRAWING METHOD:** Summer of Fun promotion winners will be chosen by random drawing.

5. **ODDS OF WINNING:** The odds of winning a prize via the Summer of Fun promotion are based on the total number of entries each week.

6. **PRIZE ALLOCATION:** The prizes awarded will be specified in order on the entry form for each drawing. The prizes awarded in each Summer of Fun drawing shall be allocated in the order of the entries selected.

7. **CONTACTING WINNERS:** Each winning Summer of Fun entrant will be notified by certified mail. If there is no response within 10 days of the Mississippi Lottery receiving confirmation of the certified mail being delivered, including the drawing date, the Lottery may attempt to contact the winning entrant by email and/or telephone to arrange prize pick up, or in the case of gift cards, delivery.

8. **PRIZE PICK UP:** Summer of Fun promotion winners will have 30 calendar days after the Mississippi Lottery receives confirmation of the delivery of the notification letter to pick up his/her prize as directed by the notification letter. If the confirmation delivery is not received within 10 days after the Mississippi

Lottery mails the certified letter, the Lottery may attempt to contact the winner by telephone and/or by email.

9. **WINNER REQUIREMENTS:** Each Summer of Fun promotion winner will be required to submit proper identification and complete a winner claim form – the same process used for prize claims for MLC games. Gift card winners may download a claim form or be emailed the proper form and submit their claim by mail along with a photocopy of the required identification. Claims made by mail must be received by the Lottery within the specified prize claim period. The Mississippi Lottery is not responsible for lost or stolen mail, and claims received after the deadline will be rejected.

10. **WINNERS LIST:** The Mississippi Lottery will maintain a list of Summer of Fun winners and may publicize the winners' hometowns or home counties on the Mississippi Lottery website, via social media or other means.

11. **NO PRIZE EXCHANGE:** All Summer of Fun promotion prizes will be awarded as described. No substitutions.

12. **TAXES:** The initial sales taxes and initial title and registration fees associated with the acceptance of the prize shall be paid by the MLC.. Other taxes and fees associated with the acceptance, ownership and use of the prize, including but not limited to insurance premiums, transportation expenses and subsequent tax, title and registration fees, are the responsibility of the winner, and shall not be paid by the MLC. All federal, state and local taxes on the total prize value, if applicable, are the responsibility of the winner. MLC will withhold and deposit all applicable state and federal taxes on behalf of the winner, based on the prize value. An IRS Form 1099 will be issued to the winner as required by law.

13. **WATERCRAFT AVAILABILITY:** Due to supply shortages, watercraft may need to be ordered and delivery time may vary.

14. **INSURANCE:** Insurance for any prize in the Summer of Fun promotion is solely the responsibility of the winner.

15. **RELEASE OF LIABILITY:** All entrants in the Summer of Fun promotion agree the MLC shall have no liability for any personal injuries, death, property damage, or other damage or expenses resulting from or arising out of any aspect of use or acceptance of the prize.

16. **DISPUTE RESOLUTION:** The venue for any dispute arising under and/or as a result of the Summer of Fun promotion shall be the appropriate court in Rankin County, Mississippi.
